of his work experience. Photo copy of PAN Card is also to be submitted.

The successful tenderer will be required to deposit 10% of the total work value as Security Deposit in the same form in which the Earnest money has been deposited to the Trustees of Victoria Memorial before receiving of Work Order. The earnest money will be forfeited if the Security Money is not deposited within seven days from the date of intimation in this regard or if the successful tenderer is unable to execute the job within specified time.

The successful tenderer will be required to complete the allotted job within 07 days from the date of receipt of the Work Order failing which their SD shall be liable to be forfeited without any further intimation.

The job executed by the successful tenderer shall be guaranteed against bad workmanship for a period of six (6) months from the date of completion of the job. If any defect during the period as mentioned above is detected, he will be liable to rectify the same free of cost within reasonable time.

The job to be executed is scheduled to be inspected by the concerned unit of the VMH.

The job to be executed will follow the Govt. specification.
