The Tenders will be opened on the same day at 3:00 pm in the presence of such tenderers or their representatives who wish to remain present.

Tenders in sealed cover should be superscribed “Supply Led Strip”.

Rates so quoted will remain valid for six months.

Rates should be quoted inclusive of GST and transportation charges etc. The rate should be quoted both in words and figures. The tenderers should clearly state the delivery schedule.

The Tenders should be submitted on the letterhead of the firm.

The tenderers should have sufficient experience in doing similar nature of jobs preferably in Govt. Sector. The tenderers should submit photocopies of their licences, GST Registration Certificate, PAN card and papers in support of their work experience.

The successful tenderer will be required to deposit 10% of the total work value as Security Deposit in the same form of Demand Draft in favour of Victoria Memorial Hall, drawn from any commercial bank, payable at Kolkata before receiving of Work Order. The security money since deposited will be refunded not earlier than six (06) month from the date of completion of the job. The Security Money will be forfeited if the successful tenderer is unable to commence the job and complete the same within the specified time.

The job executed by the successful tenderer shall have to be guaranteed against bad workmanship for a period of six (6) months from the date of completion of the job. If any defect is detected during the period as mentioned above, he will be liable to rectify the same free of cost within reasonable time. Otherwise, VMH will get it rectified at its own cost and adjust the same from the Security Deposit.

The job to be executed is scheduled to be inspected by the concerned unit of the VMH.

The job to be executed will follow the Govt. specification.

The job under reference should be completed within 3 days from the date of receipt of final work order.

For any additional information / physical inspection of the sample/ model, tenderers may contact the Electrician (9883224028) of this office between 2:00 pm to 4:00 pm on any working day with prior intimation.
