Tenderers are to submit papers about their experience, Pan Card, GST certificate etc (all photo copies) alongwith tenders.

The tenders will be opened on the same day at 3.00 p.m. in the chamber of the Accounts officer. Tenderers/their representatives may remain present at the time of opening of tender if they so desire.

The rate should be inclusive of all charges i.e. labour, materials, transportation, and taxes, if any. The amount should be quoted **rate per square foot** (both in words and figures). The contract would be for a period of 02(two years) starting from 01.10.2021 and it may be renewed for further period after satisfactory completion of schedule period. The work should be done with best quality ISI marked approved brand and shade paints, materials within the stipulated period under the supervision of the Caretaker. Tenderers may inspect the site on any working day, during working hours before submission of tenders.

However, if any deficiencies are noticed during the currency of the contract period or any contractual dispute, the contract can be terminated by giving both parties with 01(one) month's prior written notice.

SCOPE TO WORKS FOR PAINTING WORKS

Sl.no.	Description
1.	Cleaning of walls, ceiling, panels, Staircases etc.
2.	Removal of plastic emulsion paints
3.	Repairing of damaged areas as and where required
	Apply damp proof of approved brand as and where required
4.	Providing and applying wall putty of approved brand
5.	Apply one coat of primer of approved brand
6.	Painting with luxury emulsion washable paints of approved brand and shade for interior walls
7.	Painting with emulsion weather coat paints of approved brand and shade for outer walls
