The tender in sealed cover should be superscribed with "Tender for painting works" must be sent to the office of the Secretary & Curator, Victoria Memorial Hall within 02 p.m. on 13.04.2022. Tenderers are to submit papers about their experience, Pan Card, GST certificate etc (all photo copies) alongwith tenders.

The tenders will be opened on the same day at 3.00 p.m. in the chamber of the Accounts officer. Tenderers/their representatives may remain present at the time of opening of tender if they so desire. The tender should be accompanied by an EMD @ 2% of the estimated value of the contract in the form of an a/c payee Demand Draft drawn in favour of "Victoria Memorial Hall' payable at Kolkata. The Successful bidder will have to deposit performance security @ 5% of the estimated value of the contract. The EMD of the unsuccessful bidders will be returned latest on or before the 30<sup>th</sup> day after the award of the contract. Performance security should remain valid for a period of sixty days beyond the date of all contractual obligations. EMD will be refunded to the successful bidder on receipt of performance security.

The rate should be inclusive of all charges i.e. labour, materials, transportation, and taxes, if any. The amount should be quoted both in words and figures. The work should be done with best quality ISI marked approved brand and shade paints, materials within the stipulated period under the supervision of the Caretaker. Tenderers may inspect the site on any working day, during working hours before submission of tenders.
