Notice Inviting Tender

Sealed Tenders are invited by the Victoria memorial Hall from licensed electrical contractors for the work as mentioned below:

Name of Work:

"Supply, laying and fixing of 200 sqmm underground armoured aluminium cable from T1 switch room to T1 panel located inside the Victoria Memorial building premises, Kolkata, during 2023-24." (Schedule of Work enclosed vide Annexure – 1)

The Sealed tenders on the Letter Head of the firm and addressed to the Secretary & Curator, Victoria Memorial Hall, 1 - Queens Way, Kolkata 700071, should be dropped in the tender box kept for the purpose in the office of the undersigned on or before 2:00 pm on 12.03.24. The Tenders will be opened on the same day at 2:30 pm in the presence of such tenderers or their representatives who wish to remain present.

Tenders in sealed cover should be superscribed "Supply, laying and fixing of 150 sqmm underground armoured aluminium cable T1 from switch room to T1 panel located inside the Victoria Memorial building premises, Kolkata, during 2023-24."

Rates so quoted will remain valid for six months.

Rates should be quoted inclusive of taxes (mentioning the tax rate) and transportation charges etc. The rate should be quoted both in words and figures. The job should be started within 7 days and completed within 30 days from the date of receipt of Work Order.

The tenderers should have sufficient experience in doing similar nature of jobs preferably in Govt. Sector. The tenderers should submit photocopies of their licences, PAN card, GSTIN (GSTR-1, GSTR-3B) documents and papers in support of their work experience.

The tenderers will be required to deposit 3% of the quoted rates as Earnest Money in the form of Demand Drafts in favour of the "Victoria Memorial Hall", drawn from any commercial bank, payable at Kolkata. However, the tenderers who are exempted from furnishing EMD as per GOI orders need not furnish EMD, subject to submission of necessary supporting papers. The above earnest money will be refunded after one month from the date of issuance of Work Order. The EMD's of unsuccessful tenderers shall be released after the issuance of work order or latest by one month

The successful tenderer will be required to deposit 10% of the total work value as Security Deposit in the same form in which the Earnest money has been deposited to the Victoria Memorial Hall before receiving of Work Order. The security money since deposited will be refunded not earlier than Eight month from the date of completion of the job. The earnest money will be forfeited if the Security Money is not deposited within seven days from the date of intimation in this regard or if the successful tenderer is unable to commence the job within specified time. The Security Money will be forfeited if the allotted work is not started within seven days from the date of intimation or completed within scheduled time frame.

The job executed by the successful tenderer shall have to be guaranteed against bad workmanship for a period of six (6) months from the date of completion of the job. If any defect is detected during the period as mentioned above, he will be liable to rectify the same free of cost within reasonable time. Otherwise, VMH will get it rectified at its own cost and adjust the same from the Security Deposit.

The job to be executed is scheduled to be inspected by the concerned unit of the VMH.
