The sealed quotation must reach the office on or before 2:00 PM on  $\frac{15}{04}$ /2024. The same will be opened on the same day at 2:30 PM in presence of such quotationers who wish to remain present.

#### **General Terms and Conditions:**

- 1. The quotation may be submitted on the letter head of the firm.
- 2. The quotation in sealed cover should be super scribed "Tender for the supply of Computer Monitor and buyback of Old Computer Monitor" and addressed to Secretary & Curator, Victoria Memorial Hall, 1 Queen's Way, Kolkata-71.
- 3. The rate should be quoted inclusive of GST, Transportation, delivery and installation charge etc. The rate should be quoted both in word and figures. The tenderer should clearly state the delivery schedule.
- 4. All the material supplied to have a warranty of one year from the date of successful installation of the equipment.
- 5. The material to be supplied will be inspected by concerned officer of Victoria Memorial Hall for desired specification and quality.
- 6. The rate should be quoted for both supply of new Monitors and buy back of old Monitors separately.
- 7. Photocopies of following documents are to be submitted along with the quotation A) PAN Card, B) Credential showing supply of monitors to other organizations, specially Government Organizations, C) Documents showing authorized dealership/distributorship/reseller of the company, GST Certificate.
- 8. Quotationers are required to deposit earnest money @2% of value of quotation in the form of Bank Draft on any nationalized bank in favor of the "Victoria Memorial Hall", payable at Kolkata. However the tenderer who are exempted from furnishing EMD as per G.O.I Orders need not furnish EMD, subject to submission of necessary supporting papers.
- 9. Rats should be valid for three (03) months.
- 10. Materials should be supplied within 15 days from the date of acceptance of the tender.
