Tender Notice

Victoria Memorial Hall, 1 Queen's Way, Kolkata 700071 (2223-0953) invites sealed tenders from registered & qualified agencies for cutting and disposal/removal of one very tall Debdaru tree (Polyalthia longifolia) which is dangerously inclined towards the administrative Building. The tender in sealed cover should be superscribed with "Tender for cutting and disposal/removal of one very tall Debdaru tree" and should be sent to the Secretary & Curator, Victoria Memorial Hall within 1 p.m. on 22-4294.

The tenders will be opened on the same day at 2.30 p.m. in the office chamber of the Accounts Officer. Tenderers/their representatives may remain present at the time of opening of tender, if they so desire.

The tender should be accompanied by an earnest money deposit of Rs.2000.00 (Rupees two thousand only) in the form of a Bank draft drawn in the favour of "Victoria Memorial Hall" payable at Kolkata. Please note that tender without the earnest money will be rejected outright. However the tenderers who are exempted from furnishing EMD as per GOI orders need not furnish EMD, subject to submission of necessary supporting papers.

The rates should be quoted both in words and figures. The successful tenderer will be required to cutting and remove the branches and trees within 15 days of the receipt of work order at their own cost from "as is where is basis". The selected agency will have to submit 5% of the quoted amount in the form of Bank Draft as performance security drawn in favour of "Victoria Memorial Hall" Payable at Kolkata, which should remain valid for a period of sixty days beyond the date of completion of all contractual obligations of the agency. The EMD already furnished may be adjusted from performance Security if the agency agrees to it.

The intending tenderers are requested to visit the site and make on the spot inspection of the type and quality of tree VMH desires to dispose off. The successful tenderer will be required to deposit the quoted amount within 3 days of the acceptance of the tender failing which the tender will be rejected. For more details they may contact the Security Officer, VMH on any working day between 9.45 a.m to 5.15 p.m.

VM H reserves the right of rejection of any or all tenders without assigning any reason.
